

This institute will focus on developing strategies with state Part C or 619 coordinators to integrate infants and young children who receive services under IDEA into statewide early childhood activities. Follow-up to the institute participants will include coaching using technology and the provision of training materials to scale up involvement of the Part C and B (619) coordinators in early childhood state policy and program development.

## Objectives

By the end of the 2.5 day institute, the participants will be able to:

- 1) Describe the history, structure and workforce needs of the early childhood community.
- 2) Describe the history, structure and workforce needs of the early childhood intervention community.
- 3) Describe strategies to integrate infants and young children with disabilities and families into state wide early childhood programs, including ELC activities.
- 4) Describe strategies to integrate personnel who serve infants and young children with disabilities and families into state wide early childhood programs.
- 5) Describe leadership roles and responsibilities for the Part C and 610 coordinators to facilitate the inclusion infants and young children with disabilities and families into state and local early childhood initiatives including personnel development, QRIS and child and family benchmarks and outcomes.
- 6) Develop a state plan, timelines and outcomes to use in their state to facilitate the inclusion infants and young children with disabilities and families into state and local early childhood initiatives.
