What is Advocacy?

- Individual or collection action in support of:
 - Educating elected officials on the needs of individuals with delays/disabilities, as well as policy and services—federal/state/local focus
 - Increasing the likelihood that policies and services are implemented through evidence-based practices—state/local focus
- Professional development to multiple audiences
- Rationale: Improve the quality of decision-making leading to positive outcomes for the short- & long-term

Four Opportunities for Advocacy

- 1. Biden's Appropriations Bill: Passage
- 2. Build Back Better (American Family Plan): Passage
- 3. American Rescue Plan: Resource allocation
- 4. Biden's Appropriations Bill: Implementation of new Part C Policy



Biden's IDEA Budget for FY 2022

- \$502.6 million for Preschool 619 Grants, an increase of \$105 million from FY 2021
- \$731.9 million for Part C, an increase of \$250 million from FY 2021 appropriation; includes policy changes to Part C
- \$397.7 million request for Part D National Activities programs:
 - \$250 million for the Personnel Preparation program which is a \$160 million increase over FFY 2021
 - \$49.3 million for Technical Assistance and Dissemination, an increase of \$5 million from FFY 2021 which would support additional technical assistance efforts

First Opportunity: Passage of Appropriations Bill for FY 2022 (10/1/21-9/30/22)

- House has passed its appropriations bill and Senate Appropriations Committee is now developing specific funding levels.
- All funding bills must be passed by the full House and Senate and signed into law by President by midnight 9/30/21 unless a Continuing Resolution (CR) is passed by House and Senate. House has passed CR on party-line vote to keep funding levels through 12/3/21 and to raise the debt limit. Senate has not acted. It will require 10 Republicans to vote affirmatively for CR and debt-limit increase that has deadline of mid-to-late October.
- If passed, these funds will be made available to states through IDEA formula

Biden's Part C Agenda

Equity Plans

- Report service rates for subgroups with limited enrollment
- Identify evidence-based practices to engage subgroups
 - Outreach to remote areas & home daycare providers
 - ✓ Partnerships with local health departments & public health nurses
 - Training on implicit bias
 - ✓ Streamlining evaluation
- Use not less than 10% of annual award to develop & implement equity plan
- Document data on closing gaps



Biden's Part C Agenda (cont'd.)

- Family Fees
 - Prohibit states from charging family fees or out-of-pocket expenses
 - Department will issue guidance on best practices
- Eligibility Criteria (more restrictive guidelines lead to greater racial disparities)
 - 24-month advance notice to families of any changes in criteria
 - Department will lead collaborative effort to identify model eligibility guidelines



Biden's Part C Agenda (cont'd.)

- Part C Summer Transition Services
 - Enable states to provide summer services from Part C to Part B without current onerous regulatory requirements
 - Will seek additional future flexibility in seamless birth to five system
- Personnel and Workforce
 - Increase number of early childhood training grants
 - Make new grants to states to support state recruitment, preparation, induction, professional development, support, and retention with emphasis on increasing diversity of providers

Second Opportunity: Passage of Build Back Better Act (American Families Plan)

- \$450 billion in new early childhood funding
 - \$225 billion for Child Care for American Families Program
 - \$200 billion for universal preschool
 - \$25 billion for child care infrastructure
- Immediate advocacy is needed with Congressional delegation



CHILD CARE FOR AMERICAN FAMILIES

- -Children eligible in households earning 1.5 times the median income in their state
- Families pay no more than 7 percent of their income for child care
- Lowest income families receive free child care
- -Inclusive for children with disabilities
- Provider payments based on cost of quality, including low ratios, developmentally appropriate curriculum

Third Opportunity: Resource Allocation of American Rescue Plan (COVID-based)

Includes \$1.9 trillion with targeted one-time only IDEA funds allocated in July to lead agencies:

- \$2.5 billion for Part B
- \$200 million for Section 619
- \$250 million for Part C
- Advocacy is for use of funds

- Your name, Congressional district, city/county/town
- Your contact information (USPS, email, telephone)
- Beneficiaries of your advocacy

Crafting Your Message

- Brief
 - Provide short statements to members of Congress & staff to gain their attention
- Identify yourself
 - Congressional district & contact information
 - State why your voice matters
- Local
 - Share local connection
- Compelling

Crafting Your Message

- State the action you are requesting
 - Enact Appropriations Bill and Build Back Better
 - Support Continuing Resolution
 - Raise debt limit
- Include short- and long-term impact
 - Capsule what difference the legislation will make in quality of life for children, families, and professionals
- Seek personal connection & reciprocate
 - Issue invitations to visit programs

- Partner with lead agency to engage stakeholder input with assurance of equitable representation
- Equity Plan
 - Expand equitable representation in all leadership groups
 - Assess current status of equity in child and family outcomes

Partners in Policy Making

- Developed by the Minnesota Governor's Council on Developmental Disabilities
 https://mn.gov/mnddc/pipm/pdf/Partners_Coord_Handbook2016.pdf
- Leadership program teaching people with disabilities and parents of young children with disabilities to be long-term change policy agents.
- Groups of approximately 35 adults and parents meet for 128 hours over 8 weekends.
- Explores 11 critical topics (e.g., service coordination, inclusive education, assistive technology, parliamentary procedure & serving on boards, media skills, meeting a public official). Approximately 32,000 graduates who have, in turn, served on boards at local, state, and federal agencies

- Fostering Advocacy, Communication, Empowerment and Supports (FACES)
 - oDeveloped by Dr. Jamie Pearson at N.C. State University

- oAdvocacy program teaching African-American parents of children (ages 3-14) with autism about community resources, legal rights, parent-professional communication skills, and empowerment strategies
- o18-hour program over 6 weeks
- Research resulted in significant increase in participants' advocacy, sense of empowerment, and community support



Legislative Advocacy

- Developed by Dr. Meghan Burke, University of Illinois and Dr. Zach Rossetti, Boston University
- Extensive research over last 6 years on advocacy training with emphasis on racially diverse families
- Current study involves a legislative advocacy program teaching parents associated with six PTIs legislative advocacy skills involving generating ideas for the next IDEA reauthorization, developing expertise for legislative visits, and creating a video-taped testimonial
